4.1 Description of first aid measures

If inhaled

Assure fresh air breathing. Allow the victim to rest.

In case of skin contact

Remove affected clothing and wash all exposed skin area with mild soap and water, followed by warm water rinse.

Rinse immediately with plenty of water. Obtain medical attention if pain, blinking or redness persist.

If swallowed

Obtain emergency medical attention. Do NOT induce vomiting. Rinse mouth.

Symptoms relating to use: Not expected to present a significant hazard under anticipated conditions of normal use.
