Section 3 Hazards Identification

Section 4 First - Aid Measures

In case of contact with eyes, wash with copious amounts of water for at least 15 minutes. Assure adequate washing by separating the eyelids with fingers. In serious conditions, call a physician, show the container or label.

Extinguishing Media. Water spray. Carbon dioxide, dry chemical powder or appropriate foam. Special fire-fighting procedures. Wear selfcontained breathing apparatus and protective clothing to prevent contact with skin and eyes.

Wear respirator, chemical safety goggles, rubber boots and heavy rubber gloves. Sweep up, place in a bag and hold for waste disposal. Avoid raising dust. Ventilate area and wash spill site after material pickup is complete.
