SECTION 4: First aid measures

4.1 Description of first aid measures

General advice

If inhaled

Remove person to fresh air and keep comfortable for breathing.

In case of skin contact

In case of eye contact

4.2 Most important symptoms and effects, both acute and delayed

Danger! Corrosive and toxic liquid. Causes severe burns. Harmful if absorbed through skin. Eye contact causes tissue damage and blindness. May be fatal if swallowed. Ingestion causes corrosion of the mucosa of the mouth, throat and esophagus with stomach discomfort and pain. If ingested, dilute with large quantity of water. Do not induce vomiting. Call a physician. Wash areas of contact with plenty of water for at least 15 minutes. EYE CONTACT: Eye contact causes tissue damage and blindness. SKIN CONTACT: Skin contact causes burns, blistering, local necrosis, and membrane ulceration. Burns may be 2nd or 3rd degree. CHRONIC EFFECTS / CARCINOGENICITY: Chronic exposure through any route can produce central nervous system damage. Can cause skin allergies and accumulate in the body. Repeated skin contact can cause skin to turn gray in color due to the mercuric compound.
