SECTION 4: First aid measures

4.1 Description of first aid measures

General advice

Consult a physician. Show this safety data sheet to the doctor in attendance.

If inhaled

Symptoms relating to use: Causes severe skin burns and eye damage. May cause respiratory irritation.
