SECTION 4: First aid measures

4.1 Description of first aid measures

General advice

Consult a physician. Show this safety data sheet to the doctor in attendance.

If inhaled

5.1 Extinguishing media

Combustible. Vapours are heavier than air and may spread along floors. Forms explosive mixtures with air at ambient temperatures. Pay attention to flashback.

Special protective equipment for firefighters

Stay in danger area only with self-contained breathing apparatus. Prevent skin contact by keeping a safe distance or by wearing suitable protective clothing.
