SECTION 4: First aid measures

4.1 Description of first aid measures

General advice

Consult a physician. Show this safety data sheet to the doctor in attendance.

If inhaled

Remove to fresh air and keep at rest in a position comfortable for breathing. Immediately call a POISON CENTER or doctor.

In case of skin contact
