SECTION 4: First aid measures

4.1 Description of first aid measures

General advice

Consult a physician. Show this safety data sheet to the doctor in attendance.

If inhaled

Remove to fresh air and keep at rest in a position comfortable for breathing. Immediately call a POISON CENTER or doctor.

In case of skin contact

Remove/Take off immediately all contaminated clothing. Immediately call a POISON CENTER or doctor. Wash with plenty of soap and water.

In case of eye contact

Get medical advice. If eye irritation persists : Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTER or doctor.

If swallowed

Immediately call a POISON CENTER or doctor. Do NOT induce vomiting. Rinse mouth.

4.2 Most important symptoms and effects, both acute and delayed

Symptoms relating to use: Suspected of damaging the unborn child, Causes severe skin burns and eye damage, Suspected of damaging fertility, Causes serious eye irritation.

4.3 Indication of any immediate medical attention and special treatment needed

Never give anything by mouth to an unconscious person. If exposed or concerned: get medical advice.

5.1 Extinguishing media
