Dizziness, Central nervous system depression, Aspiration or inhalation may cause chemical pneumonitis., MTBE (methyl-tert-butyl ether) is reported to metabolize to tert-butyl alcohol and formaldehyde by microsomal demethylation, MTBE (methyl-tert-butyl ether) should be considered a "potential human carcinogen" based on the results of studies in male rats and an increase in lymphomas, leukemias, and adenomas of the testes in male rats and an increase in the incidence of hepatocellular adenomas in female rats. In another unpublished study MTBE was shown to be carcinogenic due to "increased incidence of hepatocellular adenomas" in female rats. To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.
