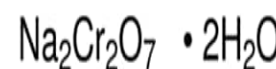

Wash hands thoroughly after handling. Keep away from heat. Do not eat, drink or smoke when using this product. Take any precaution to avoid mixing with combustible or incompatible materials.</p> <p><b>Response :</b> If skin irritation or rash occurs, seek medical advice/attention.
