

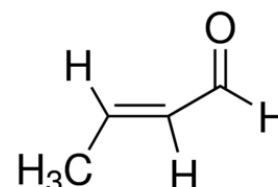

### DANGER

### PRECAUTIONARY STATEMENTS :

**Prevention :** Wash thoroughly after handling. Avoid breathing dust/fume/gas/mist/vapours/spray. Wash hands thoroughly after handling. Ground/bond container and receiving equipment. Do not eat, drink or smoke when using this product. Do not breathe dust/fume/gas/mist/vapours/spray. Use only outdoors or in a well ventilated area. Wear protective gloves/clothing. Wear respiratory protection. Keep container tightly closed. Wear protective gloves and eye/face protection. Keep away from heat/sparks/open flame - No smoking. Contaminated clothing should not be allowed out of the workplace. Take precautionary measures against static discharge. Use only non-sparking tools. Use explosion-proof electrical/ventilating/lighting/equipment.

**Response :** Immediately call a POISON CENTER or doctor/physician. If eye irritation persists, get medical advice/attention. If skin irritation occurs, seek medical advice/attention. If skin irritation or rash occurs, seek medical advice/attention. Wash contaminated clothing before reuse. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Wear eye/face protection. IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. Specific treatment: refer to Label or MSDS. Call a POISON CENTER or doctor/physician if you feel unwell. Remove/Take off immediately all contaminated clothing. Get medical advice/attention if you feel unwell. If on skin or hair: remove/take off immediately all contaminated clothing. Rinse with water/shower. IF SWALLOWED: Immediately call a POISON CENTER or doctor/physician. IF ON SKIN: Gently wash with plenty of soap and water. Wash/Decontaminate removed clothing before reuse.

**Disposal :** Aldehyde is blanketed with sodium sulphite and then mixed with water. After completion of the reaction, dispose off.
