### DANGER

Wash thoroughly after handling. Ground/bond container and receiving equipment. Use explosion-proof electrical/ventilating/lighting/equipment. Take precautionary measures against static discharge. Use only non-sparking tools. Keep away from heat/sparks/open flame - No smoking. Keep container tightly closed. Wear protective gloves and eye/face protection.

**Response :** In case of fire, use alcohol-type foam for extinction. Wash contaminated clothing before reuse. IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. If on skin or hair: remove/take off immediately all contaminated clothing. Rinse with water/shower.
