

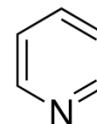

### DANGER

If on skin or hair: remove/take off immediately all contaminated clothing. Rinse with water/shower. Specific treatment: refer to Label or MSDS. In case of fire, use alcohol-type foam for extinction. Call a POISON CENTER or doctor/physician if you feel unwell. IF ON SKIN: Gently wash with plenty of soap and water.
