

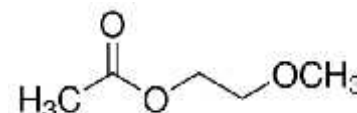

<p>DANGER</p> <p>HAZARD STATEMENTS : May cause respiratory irritation. May cause drowsiness or dizziness. Highly flammable liquid and vapour. May be harmful if swallowed. Harmful to aquatic life.</p> <p>PRECAUTIONARY STATEMENTS : Prevention : Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Keep container tightly closed. Ground/bond container and receiving equipment. Use explosion-proof electrical/ventilating/lighting equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Avoid breathing dust/fume/gas/mist/vapours/spray. Wash thoroughly after handling. Use only outdoors or in a well-ventilated area. Avoid release to the environment. Wear protective gloves/protective clothing/eye protection/face protection.</p> <p>Response : IF SWALLOWED: Immediately call a POISON CENTER or doctor/physician. IF ON SKIN (or hair): Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower. IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Call a POISON CENTER or doctor/physician if you feel unwell. Do NOT induce vomiting. If skin irritation occurs: Get medical advice/ attention. If eye irritation persists: Get medical advice/attention.</p> <p>Disposal : Allow to evaporate in safe open area (applicable for small quantities). The chemical should be burnt in a chemical incinerator equipped with burner and scrubber.
