PRECAUTIONARY STATEMENTS

Prevention: Wash hands thoroughly after handling. Ground/bond container and receiving equipment. Do not eat, drink or smoke when using this product. Wash thoroughly after handling. Do not breathe dust/fume/gas/mist/vapours/spray. Avoid breathing dust/fume/gas/mist/vapours/spray. Use only outdoors or in a well ventilated area. Use only non-sparking tools. Use personal protective equipment as required. Keep container tightly closed. Do not handle until all safety precautions have been read and understood. Obtain special instructions before use. Wear protective gloves and eye/face protection. Keep away from heat/sparks/open flame - No smoking. Take precautionary measures against static discharge. Use explosion proof electrical/ventilating/lighting/equipment

Response: If exposed or concerned: Get medical attention advice. IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. Wear eye/face protection. If eye irritation persists, get medical advice/attention. If skin irritation occurs, seek medical advice/attention. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. If on skin or hair: remove/take off immediately all contaminated clothing. Disposal: Allow to evaporate in safe open area (applicable for small quantities). The chemical should be burnt in a chemical incinerator equipped with burner and scrubber. If the volumes are larger than 500ml and no incinerator and site of evaporation is not available then transfer the waste chemical to waste solvent drum for collection by specialist disposal company.
