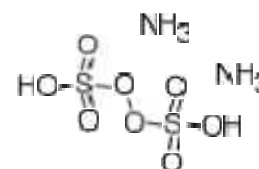

DANGER

Remove contact lenses, if present and easy to do. Continue rinsing. Remove/Take off immediately all contaminated clothing. Specific treatment: refer to Label or MSDS. Wash/Decontaminate removed clothing before reuse. Wash contaminated clothing before reuse. IF ON SKIN: Gently wash with plenty of soap and water.
