HAZARD STATMENTS : Flammable liquid and vapour. Toxic if inhaled. Harmful contact with skin. Harmful if swallowed. May cause allergic or asthmatic symptoms or breathing difficulties if inhaled. May cause allergic skin reaction. May be corrosive to metals. Causes severe skin burns and eye damage.

PRECAUTIONARY STATEMENTS :

Wash thoroughly after handling. Ground/bond container and receiving equipment. Use explosion-proof electrical/ventilating/lighting/equipment. Take precautionary measures against static discharge. Use only non-sparking tools. Keep away from heat/sparks/open flame - No smoking. Keep container tightly closed. Wear protective gloves and eye/face protection.

Response : In case of fire, use alcohol-type foam for extinction. Wash contaminated clothing before reuse. IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. If on skin or hair: remove/take off immediately all contaminated clothing. Rinse with water/shower. If experiencing respiratory symptoms call a POISON CENTER or doctor/physician. Absorb spillage to prevent material damage. If skin irritation or rash occurs, seek medical advice/attention. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. IF INHALED: If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. IF ON SKIN: Gently wash with plenty of soap and water.
