Application: An antimicrobial Supplement recommended for the selective cultivation of yeasts and moulds.

Composition**

Per vial sufficient for 1000 ml medium

IngredientConcentrationTetracycline100mgSodium benzyl penicillin100mg

Directions

Rehydrate the contents of one vial aseptically with 5 ml sterile distilled water. Mix well and aseptically add to 1000 mlof sterile molten, cooled (45-50°C) Sabouraud Glucose Agar w/ Antibiotics (DM2472 / DM2472B / DM2472E)/ Sabouraud Dextrose Agar Medium w/
Tetracycline (DM2472M). Mix well and dispense as desired

Type of specimen

Clinical samples - Skin scrapping, nail scrapings, etc.

Specimen Collection and Handling

For clinical samples follow appropriate techniques for handling specimens as per established guidelines (1, 2). After use, contaminated materials must be sterilized by autoclaving before discarding.

Store at 2-8°C. Use before expiry date on the label.
