Prevention: Ground/bond container and receiving equipment. Use only nonsparking tools. Take precautionary

Keep container tightly closed. Use explosion-proof electrical/ventilating/lighting/equipment. Wear protective gloves and eye/face protection. advice/attention. IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Disposal: Allow to evaporate in safe open area (applicable for small quantities). The chemical should be burnt in a chemical incinerator equipped with burner and scrubber. If the volumes are larger than 500ml and no incinerator and site of evaporation is not available then transfer the waste chemical to waste solvent drum for collection by specialist disposal company.
