Application:- Dulbecco's Modified Eagle Medium /Nutrient Mixture F12 Ham (DMEM/F12, 1:1 mixture) was originally formulated for rat neuroblastoma cells and MDCK cells. The mixture is extremely nutritious and supports growth of a wide variety of cells including certain epithelial, endothelial and granulosa cells.

AT1147A is DMEM/Nutrient Mixture F-12 Ham with trace elements. It does not contain HEPES buffer. Users are advised to review the literature for recommendations regarding medium supplementation and physiological growth requirements specific for different cell lines.

Methodology

- 1. Suspend 11.7gms in 900ml tissue culture grade water with constant, gentle stirring until the powder is completely dissolved. Do not heat the water.
- 2. Add 1.2gms of sodium bicarbonate powder (TC1230) or 16ml of 7.5% sodium bicarbonate solution (TCL1013) and 0.365gms of L-glutamine powder (TC1243) or 12.5ml of 200mM L-glutamine solution (TCL1012) for 1 litre of medium and stir until dissolved.
- 3. Adjust the pH to 0.2 0.3 pH units below the desired pH using 1N HCl or 1N NaOH since the pH tends to rise during filtration.
- 4. Make up the final volume to 1000ml with tissue culture grade water.
- 5. Sterilize the medium immediately by filtering through a sterile membrane filter with a porosity of 0.22 micron or less, using positive pressure rather than vacuum to minimize the loss of carbon dioxide.
- 6. Aseptically add sterile supplements as required and dispense the desired amount of sterile medium into sterile containers.
- 7. Store liquid medium at 2-8°C and in dark till use.

Cultural Response

The growth promotion capacity of the medium is assessed qualitatively by analyzing the cells for the morphology and quantitatively by estimating the cell counts and comparing it with a control medium through minimum three subcultures. **Endotoxin Content**

Storage and Shelf Life

- 1. All the powdered media and prepared liquid culture media should be stored at 2-8°C. Use before the expiry date. In spite of above recommended storage condition, certain powdered medium may show some signs of deterioration /degradation in certain instances. This can be indicated by change in colour, change in appearance and presence of particulate matter and haziness after dissolution.
- 2. Preparation of concentrated medium is not recommended since free base amino acids and salt complexes having low solubility may precipitate in concentrated medium.
- 3. pH and sodium bicarbonate concentration of the preparedmedium are critical factors affecting cell growth. This is also influenced by amount of medium and volume of culturevessel used (surface to volume ratio). For example, in large bottles, such as Roux bottles pH tends to rise perceptibly as significant volume of carbon dioxide is released. Therefore, optimal conditions of pH, sodium bicarbonate concentration, surface to volume ratio must be determined for each cell type. We recommend stringent monitoring of pH. If needed, pH can be adjusted by using sterile 1N HCl or 1N NaOH or by bubbling in carbon dioxide.
- 4. If required, supplements can be added to the medium prior oor after filter sterilization observing sterility precautions. Shelf life of the medium will depend on the nature of supplement added to the medium.
