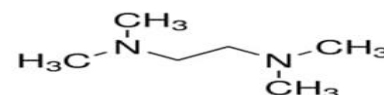

### DANGER

**Hazard statements :** Highly flammable liquid and vapour. Toxic if swallowed. Harmful if inhaled. May cause allergic or asthmatic symptoms or breathing difficulties if inhaled. May cause allergic skin reaction. Causes severe skin burns and eye damage.

IF ON SKIN: Gently wash with plenty of soap and water. Immediately call a POISON CENTER or doctor/physician
