In case of inadequate ventilation wear respiratory protection. Use personal protective equipment as required. Wear protective gloves/clothing and eye/face protection. Do not handle until all safety precautions have been read and understood. Avoid breathing dust/fume/gas/mist/vapours/spray. Obtain special instructions before use.

Response: Wash contaminated clothing before reuse. If experiencing respiratory symptoms call a POISON CENTER or doctor/physician. If exposed or concerned: Get medical attention advice. IF INHALED: If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Specific treatment: refer to Label or MSDS. If on skin or hair: remove/take off immediately all contaminated clothing. Rinse with water/ shower. Absorb spillage to prevent material damage. Immediately call a POISON CENTER or doctor/ physician. IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing.

**Disposal:** Add in small quantities to large, stirred excess of water, keeping the final concentration less than 2%. Neutralize with 5% sodium hydroxide soln. and run to waste with large volumes of running water. The chemical should be mixed combustible solvent and burnt in a chemical incinerator equipped with burner and scrubber.
