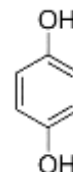

#### DANGER

**Hazard statements :** May cause respiratory irritation. Fatal if swallowed. Causes skin irritation. May cause allergic skin reaction. Suspected of causing cancer. Causes serious eye damage. Very toxic to aquatic life

#### Precautionary statements

Remove contact lenses, if present and easy to do. Continue rinsing. If skin irritation or rash occurs, seek medical advice/attention. If exposed or concerned: Get medical attention advice. If eye irritation persists, get medical advice/attention. IF ON SKIN: Gently wash with plenty of soap and water. Wash/Decontaminate removed clothing before reuse. Remove/Take off immediately all contaminated clothing. Immediately call a POISON CENTER or doctor/physician. Wash contaminated clothing before reuse. IF SWALLOWED: Immediately call a POISON CENTER or doctor/ physician. Specific treatment: refer to Label or MSDS.

**Disposal:** Dissolve the chemical to be disposed, in water and allow it to run to waste, diluting with large quantities of water. The chemical should be mixed combustible solvent and burnt in a chemical incinerator equipped with burner and scrubber
