## PRECAUTIONARY STATEMENTS:

Response: IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Immediately call a POISON CENTER or doctor/physician. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. Wash contaminated clothing before reuse. In case of fire, use dry agent for extinction. Absorb spillage to prevent material damage. In case of fire, use foam for extinction. If on skin or hair: remove/take off immediately all contaminated clothing. Rinse with water/shower. Specific treatment: refer to Label or MSDS.
