

DANGER

HAZARD STATEMENTS : Combustible Liquid. Toxic if swallowed. Causes mild skin irritation. Causes eye irritation. May cause allergic or asthmatic symptoms or breathing difficulties if inhaled. May cause allergic skin reaction.

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Specific treatment: refer to Label or MSDS. IF SWALLOWED: Immediately call a POISON CENTER or doctor/physician. Wash contaminated clothing before reuse. IF ON SKIN: Gently wash with plenty of soap and water

Disposal : The chemical should be burnt in a chemical incinerator equipped with burner and scrubber. If the volumes are larger than 500ml and no incinerator and site of evaporation is not available then transfer the waste chemical to wastesolvent drum for collection by specialist disposal company.
