

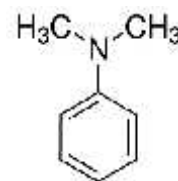

DANGER

HAZARD STATEMENTS : Combustible Liquid. Fatal if inhaled. Toxic in contact with skin. Toxic if swallowed. Causes mild skin irritation. Causes eye irritation. Suspected of causing cancer. Toxic to aquatic life with long lasting effects.

PRECAUTIONARY STATEMENTS :

Do not handle until all safety precautions have been read and understood. Obtain special instructions before use. Keep away from flames and hot surfaces.

Response : If exposed or concerned: Get medical attention advice. IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. If skin irritation occurs, seek medical advice/attention. If eye irritation persists, get medical advice/attention. Keep container tightly closed. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTER or doctor/physician. In case of fire, use foam for extinction. Call a POISON CENTER or doctor/physician if you feel unwell. IF SWALLOWED: Immediately call a POISON CENTER or doctor/physician. Specific treatment: refer to Label or MSDS. IF ON SKIN: Gently wash with plenty of soap and water. Remove/Take off immediately all contaminated clothing Wash/Decontaminate removed clothing before reuse.

Disposal: The chemical should be burnt in a chemical incinerator equipped with burner and scrubber. If the volumes are larger than 500ml and no incinerator and site of evaporation is not available then transfer the waste chemical to waste solvent drum for collection by specialist disposal company.
