



HAZARD STATEMENTS : Flammable liquid and vapour. Toxic if inhaled. Harmful contact with skin. Harmful if swallowed. May cause allergic or asthmatic symptoms or breathing difficulties if inhaled . 
Prevention : Do not breathe dust/fume/gas/mist/vapours/spray. Use only outdoors or in a well ventilated area. Avoid breathing dust/fume/gas/mist/vapours/spray. Do not eat, drink or smoke when using this product. Wash hands thoroughly after handling. Wear protective gloves/clothing. Do not breathe dust or mist. In case of inadequate ventilation wear respiratory protection. Contaminated clothing should not be allowed out of the workplace. Wear protective gloves/clothing and eye/face protection. Wash thoroughly after handling. Ground/bond container and receiving equipment. Use explosion-proof electrical/ventilating/lighting/equipment. Take precautionary measures against static discharge Use only non-sparking tools. Keep away from heat/sparks/open flame - No smoking. Keep container tightly closed. Wear protective gloves and eye/face protection.

Response : In case of fire, use alcohol-type foam for extinction. Wash contaminated clothing before reuse. IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. If on skin or hair: remove/take off immediately all contaminated clothing. Rinse with water/shower. If experiencing respiratory symptoms call a POISON CENTER or doctor/physician. Absorb spillage to prevent material damage. If skin irritation or rash occurs, seek medic advice/attention. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. IF INHALED: If breathings difficult remove to fresh air and keep at rest in a position comfortable for breathing. IF ON SKIN: Gently wash with plenty of soap and water. Immediately call a POISON CENTER or doctor/physician. Call a POISON CENTER or doctor/physician if you feel unwell. Specific treatment: refer to Label or MSDS.
