PROPERTIES

Hazard statements: Highly flammable liquid and vapour. May be harmful if swallowed. Fatal if inhaled. Toxic if swallowed. Harmful in contact with skin. Disposal: Dissolve the chemical to be disposed, in water and allow it to run to waste, diluting with large quantities of water. The quantities greater than 10g should be dissolved in water and transferred to heavy metal waste drums for collection by specialist disposal company
