

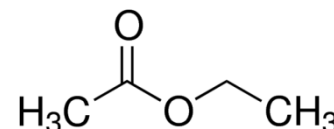

WARNING

PRECAUTIONARY STATEMENTS :

Prevention : Ground/bond container and receiving equipment. Use only nonsparking tools. Take precautionary Measures against static discharge. Wash hands thoroughly after handling. Do not eat, drink or smoke when using this product. Keep away from heat/sparks/open flame - No smoking. Keep container tightly closed. Use explosion-proof electrical/ventilating/lighting/equipment. If the volumes are larger than 500ml and no incinerator and site of evaporation is not available then transfer the waste chemical to waste solvent drum for collection by specialist disposal company.
