

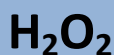

#### DANGER

**Response** : IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTER or doctor/physician. IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Keep container tightly closed. IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER or doctor/physician if you feel unwell. Specific treatment: refer to Label or MSDS. Absorb spillage to prevent material damage. In case of major fire and large quantities: Evacuate area and fight fire remotely due to the risk of explosion. If on skin or hair: remove/take off immediately all contaminated clothing. Rinse with water/shower. IF ON CLOTHING: Rinse immediately contaminated clothing and skin with plenty of water before removing clothes. Wash contaminated clothing before reuse.
