

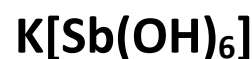

Call a POISON CENTER or doctor/physician if you feel unwell. Get medical advice/attention if you feel unwell. Rinse mouth. If skin irritation or rash occurs: Get medical advice/attention. If experiencing respiratory symptoms: Call a POISON CENTER or doctor/physician. Wash contaminated clothing before reuse. Collect spillage.

**Disposal:** Dissolve the chemical to be disposed, in water and allow it to run to waste, diluting with large quantities of water. The quantities greater than 10g should be dissolved in water and transferred to heavy metal waste drums for collection by specialist disposal company.
